Sir,

I am directed to convey the approval of Board of Governors of Medical Council of India for renewal of permission for admission of 5<sup>th</sup> batch of 150 (One Hundred Fifty) MBBS students for academic year 2011-2012 at Index Medical College Hospital & Research Centre, Indore. The Board of Governors has granted approval after consideration of the compliance verification assessment report dated 20th May, 2011 alongwith assessment dated 14<sup>th</sup> & 15<sup>th</sup> February, 2011 submitted to Board of Governors of MCI. The Permission is, however, subject to the following condition:-

- If it is found by the CBI or otherwise, at any stage, that the renewal of permission has been obtained by the college by playing fraud on MCI, proceedings in accordance with law.
- The Letter of Permission shall be subject to reducing Management quota to the extent of 45 seats as mentioned in the letter of State Govt. bearing no. 761/Admission/Record/2011 dated 20.04.2011.
- That admission process may be completed as per time schedule prescribed in the Regulations of Medical Council of India.

I am further directed to inform that you and your institution are fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical material, etc. throughout the academic year, as stipulated in Regulation of Medical Council of India. In case false/wrong declaration or fabricated documents have been used for procuring permission of the Board of Governors and the said misconduct is brought to notice or comes to the knowledge of MCI at any stage during the current academic year, your institution is not liable to be considered for renewal of permission for the next academic year and this renewal of permission is also liable to be revoked for current academic year. Besides, MCI is entitled to take all such measures against you and your college/institution as permissible under the law.
