Subject: Continuance of recognition of MBBS degree granted by Devi Ahilya Vishwa Vidyalaya in respect of students being trained at Index Medical College Hospital & Research Centre, Indore - Reg.

Sir/Madam,

I am directed to inform that an assessment to assess the physical and the other teaching facilities available for continuance of recognition of MBBS degree granted by Devi Ahilya Vishwa Vidyalaya in respect of students being trained at Index Medical College Hospital & Research Centre, Indore was carried out by the Council assessors on 5th April, 2018. The said assessment report alongwith previous assessment report (21st and 22nd December, 2017) was considered by the Executive Committee at its meeting held on 12th April, 2018 and it was decided as under:-

"The Executive Committee of the Council considered the compliance verification assessment report (5th April, 2018) alongwith previous assessment report (21st and 22nd December, 2017) and decided to revoke the decision of application of clause 8(3)(1)(c) (of Establishment of Medical College Regulation) Amendment, (2010) Part II, dated 16th April, 2010 and amended on 18.3.2016.

The Executive Committee further decided to recommend that recognition of MBBS degree granted by Devi Ahilya Vishwa Vidyalaya in respect of students being trained at Index Medical College Hospital & Research Centre, Indore be continued restricting the number of admission to 150) One Hundred Fifty (students.

The Executive Committee also decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April, 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

- (2) The recognition so granted to an Undergraduate Course for award of degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- (3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
- (4) Failure to seek timely renewal of recognition as required in sub clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

The above decision of the Executive Committee has been approved by the Oversight Committee on 19.04.2018.

It is further to inform you that your institution is fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and
